High School

Elementary

Christy Finn, Principal, stated the teachers conducted parent conferences with a good turnout. Book fair is going on this week. Saturday the PTO will be hosting their Fall Festival. Red Ribbon week is next week. Each year the campus has a big fund raiser and this year the proceeds will go towards helping the PTO purchase playground equipment. Student council members have been elected. UIL sign ups are taking place. Vertical alignment meetings are underway.

Athletics

Shay Easterwood, Athletic Director, gave an update on the fall sports. The coaching staff has started a leadership program to teach athletes to be a leader on/off the field.

DISTRICT REPORTS

Curriculum Report Richard Sweaney, Assistant Superintendent, complimented the principals for all the time and work they have done to make improvements to their campus. He gave an overview of the professional development programs that are being utilized by the campuses. The principals are working on vertical alignment. Each principal was tasked with a subject area. The core teachers then met with the principal and other teachers in the same subject area from each of the campuses to discuss and get ideas from each other. The district will be receiving a grant from Emergency Connectivity in the amount of \$175,000. This money will be used to purchase 600 Chromebooks for grades 6-12. Internal audits of the special programs continue.
