Enrollment is approximately 455 students. She thanked the maintenance department and the custodial department for their help in preparing for the new school year.
- Middle School Lori Holubec, Principal, reported the staff is working on vertical alignment with the high school campus. There have been last minute schedule changes. Approximately 165-170 parents attended Meet the Teacher Night and students received their schedules. Enrollment is approximately 230 students. Writer's Workshop and Life School are two initiatives that will be added this year. Complimented the custodial and maintenance departments for their much appreciated help.
- High SchoolLogan Lacy, Principal, stated the campus energy is great. Students and
staff are excited about the changes. The theme this year is "Build the Boat"
and explained the meaning behind the slogan. Enrollment is approximately
299 students. Schedule changes are being made. Thanked the board for
the \$500 check the staff received.
